Inactive or Dormant Accounts



Do you have an account that you have not used in a while? If so, it could become an inactive account.

We will be reviewing inactive accounts in April. Accounts with no activity for 365 days (12 months) are considered inactive and will be charged a \$10 inactive fee. If the account has had no activity for 5 years or more, SC Abandoned Property Act requires all financial institutions to turn over the funds in the account to the state.

Fraud Tips: Don't be a Victim!

TECH SUPPORT SCAMS

If a pop-up or error message appears on a website you visit and it has a phone number, DON'T call the number. These fake error messages aim to scare you into calling their "technical support hotline".

PHISHING EMAIL SCAMS

If you get an email that you are being charged for antivirus software, DON'T cancel the order or call them back.

PHONE SCAMS

DON'T answer unsolicited calls from people claiming to work for a government agency, free product trials, warranty expiring, etc. Ignore or Hang Up! If you call or answer the phone for these scams, YOU WILL GET CONNECTED TO A SCAMMER!

DON'T give personal or financial data or send money to people you don't know! If you are instructed to deposit cash at Bitcoin ATMs, buy gift cards, pay for service or send money back, IT'S A SCAM!
