We will be reviewing inactive accounts in April. Accounts with no activity for 365 days (12 months) are considered inactive and will be charged a \$10 inactive fee. If the account has had no activity for 5 years or more, SC Abandoned Property Act requires all financial institutions to turn over the funds in the account to the state.
