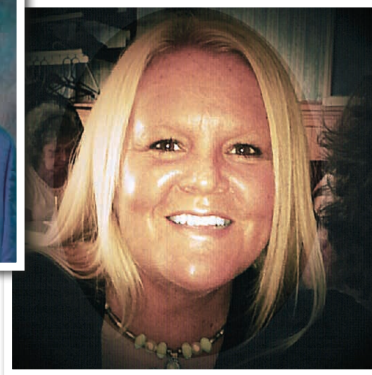

Fraud Spoofing

In an attempt to obtain sensitive information, fraudsters are using spoofing technology to make phone calls appear to be coming from a legitimate business.

Some of our members have received spoofed calls from individuals claiming to be from PDFCU, and the caller ID also indicates PDFCU. The fraudster claims that a fraudulent charge is on your account and then asks you to confirm your identity. Be assured that PDFCU actively monitors your account for suspicious activities and we will never initiate a call or text asking you for your online login credentials, debit card, PIN or account number.
